## QUESTION(S) & ANSWER(S)

**Q:** Lassen County received a request to score a client presentencing, but it would be hard to do that only with a charge and not a conviction. What should we do?

**A:** Ms. Ramos indicated that probation may score the individual, but should not submit the score to DOJ unless the person is convicted and requires registration. Language in the narrative paragraph will need to be adjusted to include this type of situation. Riverside county probation indicated that they have pre-plea language. Riverside County probation will contact Dr. Chankin with the language.
