- ✿ **CONTAINMENT MODEL DATA COLLECTION:** SARATSO is in the process of cleaning up the Containment Model data for analysis. **Please do not submit data on July 31, 2019.**
- ✿ **RISK ASSESSMENT UNIT UPDATE- 2018 SCORE SUBMISSION REPORT:** The DOJ Risk Assessment Unit (RAU) will release the 2018 Score Submission statistics at the SARATSO meeting on July 11, 2019. Statistics are broken-down into the Stable-2007, LS/CMI, and Static99-R. As a kind reminder, please only submit the FOS and Static99-R score if the person is a sex offender registrant. If counties have questions about missing scores, they can contact DOJ at CAHRISO@doj.ca.gov; this information is also on the FOS, and in the instructions for the spreadsheets on the Stable-2007 and LS/CMI.
- ✿ **STATIC99-R WORK GROUP UPDATE:** There workgroup was productive and a number of changes are being made to the slide deck. After the slide deck is updated, SARATSO will host a webinar in July or August with trainers to go over the changes.
- ✿ **SARATSO & CASOMB CERTIFICATES:** Effective June 2019, SARATSO & CASOMB will only be distributing electronic certificates.
- ✿ **CHANGE TO SARATSO MEETING SCHEDULE:** The SARATSO teleconference will take place the second Thursday of every other month after the July meeting. SARATSO staff will distribute the revised meeting schedule by close of business June 13, 2019. The revised meeting schedule will also be posted to the Certified Scorers portal at www.saratso.org.
- ✿ **BULLET REPORT CHANGE:** June is the last month that SARATSO staff will distribute a Monthly Bullet Report. Going forward, SARATSO/CASOMB staff will compile a quarterly update/bullet report that will cover both SARATSO and CASOMB topics. SARATSO will email out a notice and link to interested parties that the update is available. The Quarterly updates will also be available on the web at www.saratso.org.
