LS/CMI & Stable/Acute Score Submission Timeframes

As a kind reminder, the initial LS/CMI (i) & Stable/Acute (dynamic) score submission timeframes will be changing effective *January 1, 2021*. The score submission timeframe for both assessment tools will be decreased from 90-120 days down to 30-60 days. Please ensure that you begin scoring your clients in the specified timeframe.

NEW! LS/CMI Unable to Score Submission Spreadsheet

In order to improve upon Violence Risk Assessment (LS/CMI) score submissions, SARATSO will be implementing a new spreadsheet for treatment providers to report clients they are unable to score to the supervising officer, who will submit to the Department of Justice (DOJ). The spreadsheet will be available for use beginning on January 1, 2021.

Expiring CASOMB Certification

As a kind reminder to begin the New Year, please ensure that your direct contact information (i.e., email address) is up-to-date so that you receive proper communication from CASOMB regarding certification. If your contact information has changed, please email CASOMB@cdcr.ca.gov.

Of note, please remember that you must recertify your CASOMB certification every two years. The Board's staff will make reasonable efforts to provide advance notice of each certified provider's recertification date, but the final responsibility for tracking recertification will remain with each provider.

Did you know... that the CASOMB board meetings and sub-committee meetings are open to the public? Although CASOMB has transitioned to online meetings, the dates, times, and registration information of all meetings are posted to the CASOMB Meetings tab of the website.



MEET THE BOARD:

Los Angeles Police Department (LAPD) Detective, Lauren Rauch, began his career in law enforcement as a police officer for the LAPD in 1989. He promoted to the rank of Detective in 1999, and then to Sergeant in 2001. Detective Rauch is assigned to LAPD's Robbery-Homicide Division as the Department's Registration Enforcement and Compliance Team (REACT) Coordinator. He currently oversees 25 investigators that are responsible for the registration and compliance enforcement of over 6,500 sex offender registrants. During his previous assignment as a REACT unit supervisor, the LAPD's Valley Bureau REACT unit successfully investigated and obtained over 500 criminal case filings related to sex offenders in violation of their registration requirements and other crimes. Detective Rauch sits on the board representing law enforcement with registration and notification responsibilities.
