## 2021 SARATSO Annual Tracking Form Results

Fifty-five of 58 counties submitted aggregate data to SARATSO for the 2021 SARATSO Annual Tracking Report. Of the counties that submitted data:

- A total of 4,523 registered sex offenders were reported as under probation supervision
- A point in time count was conducted on December 31, 2021 and reflected the following:
  - ◆ 1,956 out of 4,523 were enrolled in sex offender treatment
  - ◆ 2,568 out of 4,523 were not enrolled/ attending treatment
- The top three reasons for not attending treatment include:
  - ◆ Not Court Ordered (30%)
  - ◆ Completed Treatment (15%)
  - ◆ Terminated due to AB 1950 implementation (11%)

## 2021 DOJ Score Submission Report

The Department of Justice (DOJ) presented the preliminary statistics for the 2021 Score Submission Report:

- There was a 95% compliance rate for FOS/MOS submissions
- Stable-2007 score submission rates for registrants on probation increased.
- LS/CMI scores received from CDCR outside of those submitted via MHS are still being evaluated by DOJ. An update will be provided at the September 2022 SARATSO Meeting.

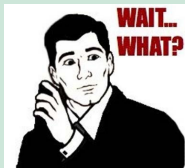
